Joe Kiser works in Community Outreach at Old National Bank. He is a senior at GVSU and has to do an internship with 100 hours of service. During May, he picked up VoYC planning process for 2020 and has been setting up the infrastructure of a planning committee and will be inviting Youth Committee and community members to participate.

Conversation around what this may look like in a time of COVID-19 and the scope of the count. Suggestion to use the count to connect youth to resources, particularly those who are currently on the by-name list (there are currently 32 homeless youth on the list). Courtney noted that it has been difficult to connect youth as there are very few resources opening. The veteran count used HMIS data as a basis to get started. Conversation around the count and modification due to COVID-19. There is potential for this to be successfully executed virtually, but a virtual count may not collect numbers that fully reflect the crisis. Agreement that a robust count would be important and will help raise awareness of the number of youth experiencing homelessness.

How do we connect with youth to help with planning? Max will try to connect with YAB members. For outreach to youth throughout the community, a youth count Facebook page/other social media could be used to share information. Potential for an informational VoYC page and then private Facebook group for youth experiencing homelessness to share information and resources with one another.
