3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This is a permanent supportive housing project designed to provide scattered site leasing assistance and supportive services for those individuals who are chronically homeless as defined by HUD. Additionally, eligible individuals must indicate that they desire housing accommodations and wish to maintain them long term; however, participation in supportive services is voluntary. Services will be provided using a strengths-based, housing first perspective with the goal of assisting homeless households to maintain permanent housing and increase their self-sufficiency.

Outreach for eligible participants will be conducted throughout the community and through the CoC utilizing the communities centralized intake referral system, the Housing Assessment Program (HAP). A core component to this project is the community-based Housing Resource Specialist (HRS) support services model. These HRS staff will engage eligible participants through outreach activities on the streets and in the local missions conducted by the coordinated entry program for Kent County, further promoting access to the project for those who are eligible. Information about the project will also be disseminated through multiple local avenues, including presenting at the CoC partner meetings which include a broad membership base. Eligible households will be assisted to locate housing within the local private rental market.

Community Rebuilders has long-standing relationships with private landlords in the local area that make it possible for participants to have choice in the private rental market.

The supportive service plan for this project is based on the standards of care adopted by our local CoC. This model utilizes a trauma-informed, strengths-based and client-centered service delivery model. The connection to the communities coordinated entry as well as comprehensive outreach efforts combined with the housing first approach will result in a low-demand model that will make access to housing simplified. The outcomes that will be tracked for this project will be consistent with the community's system-wide indicators, including tracking measures such as increasing the number of households exiting homelessness into affordable, sustainable, permanent housing, as well as maintaining housing for 6 & 12 months post services. In addition the program will track increases of income and self-sufficiency. HRS staff will provide linkages to mainstream services such as employment training, mental health and substance use treatment, physical health services and connection to other mainstream services. The foundation of the strengths-based approach and the role of the HRS is a strong, trusting and respectful relationship with participants. This approach promotes service engagement and will result in participants having greater ability to adhere to lease requirements and accomplish their goals for improved self-sufficiency.
