ICCF receives referrals for housing Coordinated Assessment & MSHDA, adheres to Housing First principles and has established a preference for chronically homeless families w/children when occupying these 2 and 3 bedroom units. The referral and screening process for PSH residents follows the procedures set by Coordinated Assessment for households who are in a housing crisis. These units will be targeted to the most vulnerable homeless members of the Kent County community. Core services include those that are needed to move people from the streets into stabilized housing. Additional services will be available in an individualized, coordinated and flexible manner including home based services during non-standard hours, life skills training, child care, education, training, health services, employment, and legal referrals. ICCF staff will meet as needed to coordinate resident services and develop eviction prevention plans when necessary to promote housing stability.
