HEROES is a scattered site permanent housing program that moves homeless, disabled veterans into permanent housing. Rental assistance and voluntary supportive services are provided to individuals to help them establish residential stability by increasing their income/benefits and self determination. Housing Resource Specialists provide support services that are trauma informed, and incorporate key strategies from solution focused and motivational interviewing. Services focus on stabilization in the neighborhood and community, linkage to service needs, and assistance with accessing benefits. Veterans are assisted, as appropriate, for their health condition to increase their income and self sufficiency. Individualized goals and action plans are developed that focus on the strengths of the individual and their hopes and dreams for the future.
