Keys First serves households with children who have been living on the streets or in emergency shelters. Screening and Assessment for entry into this project is conducted through the communities coordinated entry system at The Salvation Army Social Services Housing Assessment Program. Resources are targeted and prioritized based upon community priorities. Families who are living on the streets or in shelters and lack the financial resources and support networks to obtain housing on their own and have incomes at or below 30% of AMI are prioritized for this rapid rehousing project. Participants are expected to pay 30% of their adjusted income toward rent and may receive short or medium term assistance based on their need. Priority is placed on providing only the least amount of assistance needed by a household to obtain and maintain permanent housing. All households will be assisted to obtain housing in the private rental market and be assisted to secure a lease in the neighborhood of their choice near amenities that they most desire or need. All units meet HUD Housing Quality Standards and rent reasonableness is used to determine the applicable rent standard. All participating households will receive services from a trained Housing Resource Specialist (HRS). HRS's support the continuity of assessment and planning from early intervention through permanent housing stability. Services are based on the Housing First, strengths based model that values the consumer as a partner and expert about what is needed to obtain housing stability. Services are voluntary but a minimum requirement of monthly contact ensures specific steps to achieve goals are outlined and strengths and resources are identified and rallied to address any barriers that might interfere with housing stability. The Housing Resource Specialist provides services throughout program participation and for six months post exit from rental assistance. Services are designed to enhance participant's housing stability and self-sufficiency. HRS's assist with linkages and utilization of community resources and assist the household with the development of a homeless risk prevention plan. The non-housing related service needs of households are brokered via referral and linkages to mainstream community resources. These mainstream services include, but are not limited to employment services, mental health services, legal advocacy, disability services, primary health care, substance use disorder services, counseling, etc.

This is in reply to a letter dated August 15, 1955, from Cadwalader, Wickersham and Taft, in which they request reconaideration of our ruling issued on Hay 27, 1955, to The Salvation Army, Detroit, Michigan, holding that The Salvation Army is not a church or a convention or association of churches referred to in section 170(b)(1)(A)(i) of the Internal Revenue Code of 1954, and that such ruling be revoked. It is also requested that a ruling be issued to the effect that the National Headquarters of The Salvation Army and its various components throughout the United States constitute a church or a convention of churches as that term is used in section 170(b)(1)(A) of the

It is stated that The Salvation Army is an international unincorporated Christian Church with International Headquarters in London, England; that its churches within the United States are organized into Four Torritories under the general supervision of the National Headquarters in New York City; and that the Territories are further subdivided into 48 Divisions, each of which supervises The Salvation Army churches within a state or a part of a state.

own, established places of worship, regular congregations, regular religious services, Sunday Schools for the religious instruction of the young, and schools for the preparation of its ministers.

It is further stated that in addition to the fundamental ecclesiastical activities as a Christian Church, The Salvation Anny also conducts recreational and social programs of the same types as other churches or donominations, and that in working with the spiritually disassociated members of society The Salvation Army found it necessary to administor to the physical needs of those whom it brings spiritual Salvation. For this purpose it maintains shelters for transients, rehabilitation centers for alcoholics, homes and hospitals for unmarried mothers, visiting services for those in prison, nurseries and camps for children of abandoned mothers, and medical and dental clinics. Such activities are under the supervision of Salvation Army officers who are Ministers of the Gospel, and form an integral part of the religious program within the ecclesiastical organization of The Salvation Army.

It is further stated that The Salvation Army is recognized as a church or denomination by other Christian Churches, and has operated effectively in close conjunction with representatives of all faiths throughout local, national and international councils of churches and ministerial associations. At the first Assembly of the World Council of Churches in 1948 five Salvation Army Commanders were international representatives, and one was a member of the Central Committee. The Salvation Army is listed in the 1955 Yearbook of American Churches, published by the National Council of the Churches of Christ in the U. S. A.

Under section 170(b)(1)(A) of the 1954 Code, individuals are allowed an additional deduction of not exceeding 10 percent of their adjusted gross income for contributions made to a church or a convention or association of churches, to educational organizations referred to in section 503(b)(2), and to hospitals referred to in section 503(b)(5).

We have held The Salvation Army and its State and Regional organizations and local posts exempt from Federal income tax under the provisions of section 101(6) of the Internal Revenue Code of 1939, and that contributions made thereto are deductible by the donors in arriving at their taxable not income in the mammer and to the extent provided by section 23(a) and (q) of the 1939 Code.

Section 101(6) and section 23(c) and (q) of the 1939 Code correspond to section 501(c)(3) and section 170 of the Code of 1954.

Based upon the evidence submitted it is the opinion of this office that the National Headquarters of The Salvation Army and its various components throughout the United States constitute a church or a convention or association of churches as that term is used in section 170(b)(1)(A)(i) of the 1954 Code, and contributions made thereto are deductible by individual Joners to the extent of the special rule provided in section 170(b)(1)(A) of the 1954 Code.

The ruling dated May 27, 1955, addressed to The Salvation Army, Detroit, Michigan will be revoked.
