| <b>Coordinated Entry Planning:</b> The group has been working on expanding CE for youth. They are waiting on an MOU so that the TAY assessments can be done at HQ and the information can be provided to HAP and other agencies. At HAP, anyone under 25 is having the TAY done, unless they are parenting. The group also discussed diversion and reunification, particularly, if there is a long waitlist, what other options are there? Next step: better understand what is meant by diversion and what is happening in youth spaces across the county <b>Resource Capacity:</b> talked about the youth by-name list. They want to begin sending the number of youth on the byname list to Brianne to the committee on a monthly basis to make sure that number is at the front of everyone's minds. They are looking at ways to problem solve around connection to resources. Next meeting, they suggest that the committee look at ideas and research around case conferencing and other ways to get youth who are on the byname list into resources as quickly as possible. They are also hoping to connect with the Street Outreach committee. <b>HMIS:</b> the group talked about how HMIS could tie into VoYC and creating a timeline for the data steps around VoYC, including – contacting DV providers, entering data, viewing reports, reporting-out, etc. <b>VoYC Planning:</b> talked through the survey and suggested changes. They also discussed having staff present at the kickoff event and Come and Be Counted Sites to ensure that if a youth needs shelter, they are able to connect. United Way provided funds for gift cards or bus passes to hand out to youth at the Come and Be Counted sites. In addition, the group talked through planning for the kickoff event and decided that the purpose of the kickoff event can be two-fold: to raise awareness, as well as be a come and be counted site and provide youth with the ability to learn about resources |                                     |   |              |  |  |  |
