Foster Youth to Independence Voucher Program

Discussion

Paige Putans from DHHS attended to give an overview of the Foster Youth to Independence Tenant Protection Voucher program. 25 vouchers available through September 2021 and 25 more vouchers available Oct 2021-Sept 2022. Through this program Grand Rapids Housing Commission (GRHC) can request vouchers for up to 36 months for youth (18-24) who were involved with the foster care system and are experiencing homelessness or at risk of homelessness. Supportive services are also available, but involvement is optional. They are hoping to partner with agencies in the community to provide supportive services, connect with Paige (putansp@michigan.gov) if you are able to provide supportive services.

<u>Process</u>: Referrals go to Paige (<u>putansp@michigan.gov</u>), 616-265-0144. HAP is also working through a process to refer eligible youth directly to Paige. Paige determines eligibility of youth and refers to the GRHC. There are two documents to complete when referring over to Paige (attached in email with minutes).

Eligibility:

- Age 18-24
- Prior involvement with foster care (may be after age of 14 as this is a federal regulation for different funding streams). Suggest submitting a question to HUD to get definitive response
- Homeless or at risk of homelessness
- Youth can't receive a voucher if they are in voluntary foster care.

Jenn shared that GRHC has a competitive grant opportunity available for up to 75 additional vouchers for next fiscal year. To submit, they have to identify organizations who are committed to providing supportive services with formal signed agreement and need partners to sign updated MOU in the next 3 weeks.

Youth Functional Zero List Update

Discussion

As of this morning (2/26), there are 50 unsheltered single youth, 37 unsheltered families, and 18 sheltered youth/families for a total of 105 youth reporting homelessness in Kent County. HAP staff have been going through list and helping youth connect with FYI vouchers if eligible.

Families are connected to CHC assessment. Supportive Solutions Specialists are making direct referral to shelter. Would be helpful to understand why folks are not accessing shelter to troubleshoot and identify methods for outreach. One barrier may be that motels require an ID. Advocate at Family Promise should be able to assist families with this.

each to get the funds out. Eligibility requirements include income restrictions and a COVID-related hardship (self-attestation). There may be other requirements determined by state legislature. Cannot assist someone with section 8 or a subsidy. Once details are finalized, information will be shared widely. Once funds are available, applications can be done through an online portal or on paper.

Strategic Planning for the CoC has stated with Mission Matters as the consultant group. Planning committee looking to ensure it is a comprehensive process. If you have not received a survey to provide input, please let staff know. Hope that the CoC will have a new strategic plan to adopt by the end of June.
