Measuring Demand for Coordinated Entry

Discussion

There has been a request from Data Analysis Committee of the CoC to figure out how to measure demand on the system with reduced duplications, especially with the DV system and CHC. For example, how do we determine the demand for category 1, 2 or simply at-risk households? How do we know the demands from other populations protected by confidentiality (DV and Youth)? Do we measure on a quarterly basis? Monthly? How do we know or how do we pull that data together? How can we or how should we pull that data together?

Comments - HMIS only measures category 1 and category 2. CHC pulls info off the website but some folks who do not qualify for services attend housing hour at Community Rebuilders and are sent housing assistance info at a later date.

Questions - Do we pull info from each resource and attempt to de-duplicate? Does the decentralizing of Coordinated Entry increase the number of folks entering the system?

Discussion – Perhaps because families and individuals are contacting multiple agencies that could cause an increase or inflation of actual numbers or duplication of numbers.

Question – can we de-duplicate the folks on the CHC with HMIS?

Request for Clarification – the request from Data Analysis is to have CE look at the data – the question is why is CE the best committee to discuss this issue – example Family Promise probably had 50

families – did these families also contact TSA/HAP, CHC? If so, can we bucket these households and de-duplicate them later?

Questions - what is the standard across communities?

Comments - Looking at the current quarterly HAP info. Courtney shared screen with the TSA HAP quarterly report. Looking at this data, if we were add to the CHC does that mean we will add their numbers – even though this might be a duplication? If we are looking at the number of assessments completed.

Discussion – could the HPL/By Name List be compared to the CHC By Name List?

Comments - a higher quality by name list could help with de-duplication. Perhaps looking at the total # of assessment from each provider might also be beneficial. Look at the nature of the demand as well – Shelter request, Eviction Prevention Request, RRH and PSH request

Comments - Other communities have similar structure and work efficiently – what do those systems look like? How do those communities involve the DV populations? Comments - In the future less meetings might become normal once CE redesign is completed Question - Is there merit to have a Data Analysis member on the CE governance and oversight committee to provide expertise and coordination between the two CoC committees? Outreach providers will be adding folks to the by-name list

Comment - CHC is a google spreadsheet, google form is filled out with basic info, CHC staff remove duplications.

Question – with the singles by-name list what is that format going to be? Can HAP filter out for chronicity as there is concern with the number of individuals in the community that de-duplicating the info on a google sheet would be time consuming?

Comments - Name, contact, identifying info is all that is required to be placed on the CHC by name list. Perhaps BFZ committee can bring this up with the BFZ meeting this week.

COC staff also brought up more conversations with the DV population. There has been some connection with a national organization for technical assistance. A consultant for the CoC would not be contracted until an RFP with scope of work to integrate DV into the CE system was released.
