Federal Level – FY24 CoC Program awards were announced by HUD on January 17, however information about CoC awards was removed from the website after the OMB Memo went out and there has been no word from HUD reps about grant agreements. National partners are expecting a disruption to services and recommend continuing to spend funds down if grant agreements are under contract. Courtney encouraged attendees contact their legislators to advocate for this funding, and to determine contingency plans for funding so this community can prepare for potential gaps. A survey will go out to partners to help understand what may be at risk. She also affirmed the CoC's commitment to our values and beliefs and will not be rolling back on those in response to this administration.

100 in 100 – People are still being housed through this initiative, and there continue to be weekly discussions around scaling it up.

- a. MSHDA HCV Update Our interim process was approved but we are unsure if we will be able to draw down the HCVs. A small group is meeting Monday and we plan to have a proposal go before Coordinated Entry Committee and Steering for approval.
- b. CHC 2.0 Community Rebuilders provided an update to the Executive Committee this month. Access to the bidirectional API was granted recently and work continues to happen on that. They are working on a roadmap to provide at a future Executive Committee meeting. This committee asked about a budget, which will be included with the roadmap.

stays in contact with unsheltered families to meet basic needs, and schools have liaisons to help families connect with services, however due to fears around CPS, more families are unknown to the system.
