a) Point-in-Time (PIT) Count – Alyssa gave an overview of the PIT Count and noted this data is preliminary, as submission has been delayed for review of compliance with executive orders. She noted PIT Count numbers for 2025 seem more aligned with numbers from 2023, but does not indicate that family and youth homelessness is up.			
b) System Performance Measures – Alyssa gave an overview of the seven measures HUD looks at to determine the health and success of our system, as well as score and rank communities for CoC program competition. She reviewed SPMs 1, 2, 5, and 7, providing further context and staff analysis.

AYA broke ground on a new house yesterday, which will provide 5 additional units for youth.

Amy Lloyd (YWCA) – Movers for Moms event is taking place May 7, with all Two Men and a Truck locations accepting donations that will go directly to Project Heal. YWCA is also celebrating their 125<sup>th</sup> anniversary this year, and details on the celebration are available on their website.

Gordie Moeller shared information on the Double Up Food Bucks program in Kent County

Thelma Ensink (Degage Ministries) – The Vault is closing at the end of April, but they hope to reopen again in November. They are looking at a more permanent site for a 7-day community center to accommodate the community need, as demonstrated by over 1000 unique visitors to The Vault this winter.

Molly Perez (Kent County Health Department) – The KCHD main campus is under construction, and clients should confirm the location of their appointments ahead of time.
