Family Shelter Access: Proposed Process

Courtney states a reminder that there was a change in how families access shelter, there were concerns about equal access, so a group was created to review the process. Molly walks through new shelter access proposal and reviews process. Cheryl adds additional thoughts that were brought up in the small group meeting. Courtney reviews questions that were asked last time about questions on form and what was done.

Victoria Sluga question: Can we have a list of who participated in small group? Was the chart created in this meeting?

• Family Promise, several from ICCF, Erin and Tammy from City of Grand Rapids, Tom, Alyssa from HAP. Family Promise created the proposed process as requested by the small group. Community Rebuilders wasn't at the last meeting so there are still some things we are waiting to get their input on, changes haven't been made yet, it is still a proposed process.

Vera begins discussion on how Community Housing Connect (CHC) is involved with Coordinated Entry (CE) and its original purpose. She sees the current process changing CHC's function to one of serving families who are not literally homeless. Cheryl disagrees that there was a change in function and notes that literally homeless families in need of shelter are entered into CHC upon shelter intake.

Courtney asks to pause the conversation while questions are resolved and the group can come to a cohesive solution. She suggests technical assistance (TA) from HUD. The group agrees that staff should reach out to the HUD TA and set up a meeting with the family shelter small group. Courtney
