2. FF0 Project Tracker-Review

Temporary Housing Accommodations

- Conversations have transitioned to discussing emergency accommodations and ensuring the flow for shelter referrals is streamlined. They hope to share a plan with the group next month.

Supported Solutions

4. FF0 dashboard- Angela

- Angela overviewed the dashboard which will be fully updated later today. It was updated to show a 6 month look back period to make the view less clunky. She noted that there have been fewer permanent housing resources coming through CE this quarter.
- Lisa asked about data from last year at this time for comparison to show movement. This is not on the dashboard, but Angela can access.
- Anna noted that traditionally many projects end or start in the summer/fall which may impact openings. Angela suggested that these types of updates are shared with the group. This could be under the 'Agency Updates'

5. Review Project Tracker

- The project tracker spreadsheet was recently updated to include progress towards USICH benchmarks. Specific assessment questions were added to each goal to determine whether the goal has been met. Questions will be grouped by whether they are accomplished, on track, or need help over the next few months. This will help the group identify next steps to continue to move forward.
- The group reviewed the guestions under goal A and identify their status. Notes:
 - An outreach process specific to families would ensure all families are identified
 - Information from DV providers is needed to answer some questions
 - Further connection with education system will be needed to identify and engage doubled up families.
- 'Needs help' areas can be plugged into workgroups who can determine if additional connections are needed to support the work.
- Commissioner Morgan shared that Together West Michigan launched recently. This is a collaboration with local nonprofits, churches, and governments. He feels these organizations would be willing to provide information to community and data to the FF0 initiative.
